



DEAR SCHOLARSHIP APPLICANT:

It is a pleasure to acknowledge your request for an application with which to apply for a **GRANGE INSURANCE ASSOCIATION** (GIA) scholarship. The application is enclosed.

Applicants may apply for either an academic or a vocational scholarship. Three of the awards will be for students wishing to pursue vocational studies and 22 awards will be for academic studies. The top winner in each category will receive a \$2,500 award and the remaining winners will receive \$1,000 - \$2,000 each. Grange Insurance Association also administers awards of other privately funded scholarships.

Eligibility requirements (applicants must meet one of the following):

1. Current GIA policyholder (or child of GIA policyholder) in California, Colorado, Idaho, Oregon, Washington or Wyoming
2. Current GIA company employee (or child of current GIA company employee)
3. A previous recipient of a GIA scholarship

* Please note that children or legal wards of officers, directors or agents of GIA are **ineligible**.

These scholarships may be used at any institution offering courses leading to a certificate or degree in a recognized profession or vocation, including: community colleges, business colleges and technical institutes. Vocational grants are aimed specifically for those students not pursuing a college diploma, but seeking further education and/or training in a vocation often not covered by more traditional colleges or universities.

A copy of your high school transcript is required to confirm your GPA. However, if you are now attending college, please send us a transcript of your college grades and your scholastic placement in class, if available (upper half, upper third, etc.). It is essential that all required documents be returned in one packet to the Scholarship Committee postmarked no later than March 1, 2015. Funds awarded for the 2015-2016 school year.

Final scores will be based on the following:

- ◆ Complete & Legible Application
- ◆ Scholastic ability (copy of official grade transcript required)
- ◆ Handwritten or typed Essay by Applicant.
 - Please tell us about yourself, your family and your future goals.
 - Also include any leadership or volunteer-related programs or projects in which you have been involved in high school, in the community, or elsewhere.
 - What college, university, or trade school do you plan to attend and how will this scholarship assist you?
